

**HIGH SCHOOL TAKEOVERS METROPCS REGISTER TO WIN
OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER OR WIN**

All entry information becomes the property of the Sponsor. Sponsor reserves the right to verify all entries. No purchase is necessary to enter. A purchase will not increase chances of winning.
2. **ELIGIBILITY:** Open to legal residents of Nevada who are 18 years of age or older at time of entry. Void where prohibited by law.
